Summary Comments

This highlight report has been updated to include GD1 and GPF programmes in 1 document. In due course this will also include GD2 and other future programmes.

Growth Deal 1

Project funding agreements have been produced for the 3 FE capital and 2 business projects with SIP approval. The aim is for these to be signed soon with first claims able to be submitted during Q1 15/16.

The Business Leadership group has provided evidence for Exeter Science park conditions approval (see attached) with a recommendation that with only a few outstanding the project is allowed to sign the funding agreement and move forward.

A review of the transport projects has been carried out, which has highlighted slippage during 2015/16 but not indicated any expenditure slippages into 16/17. A similar review will be carried out with the other themes in the near future.

No approvals have been carried out since the previous report. See attached summary for programme details, which now includes the HotSW investment programmes on one sheet.

All projects are currently on track to be delivered during the programme. We are reporting amber risks on deliverability for those where key procedures need still to be met eg planning, land acquisition, and/or where cost increases are being reviewed.

A programme management guide being prepared which will provide advice on the programme management process to the decision making groups and teams delivering the programme

No change on the outputs targets - target outputs for each project will form part of the project monitoring plan which will be monitored over the life of the programme.

Science Park Centre	The building has achieved practical completion and expected to be in use from May 2015. The majority of the £4.55m loan has now been claimed, with the final claim due. Science Park Company will be making a request to HotSW LEP to change the match funding structure for the project - swapping shareholder funds to shareholder loans.	G
