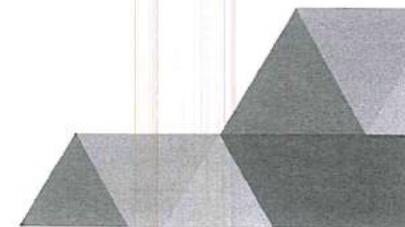
### NOTIFICATION OF CHANGE OF CIRCUMSTANCES
