3. Investment Programme Business Case and Project Changes

3.1. Torbay Western Corridor

IH updated SIP that Torbay were seeking to secure the balance of the cost increase experienced by the Torbay Western Corridor by asking the LTB and LEP to transfer £950,000 of the Local Growth Fund allocation from Torquay Gateway to Torbay Western Corridor. The recommendation had been



agreed by the LTB on 12th September.

Decision: SIP approved the recommendation to transfer the funds given assurances the transfer would not jeopardise the deliverability of Torquay Gateway. However, they pointed out that this does not set a precedent and that Torbay in this instance had put up the extra funds to help fill the gap.

3.2. Marsh Barton Station & Edginswell Station

IH updated SIP that DfT had confirmed that the unallocated funding (£4m) from the new stations fund is potentially still available for additional projects and that they recognise both stations have a good strategic case. However, it is likely that if DfT was to allocate some of the £4m it would only be to one of the 2 projects. Both Torbay and Devon Councils have meetings scheduled with the DfT in October. Both project sponsors are considering their plans and value engineering if appropriate. This had been discussed at the LTB with IH recommendations agreed. A special LTB meeting/teleconf is to take place between the 5th October DfT meetings and the November SIP meeting.

<u>Decision: SIP agreed to wait for an update from both DCC and TDC after</u> they have met with the DfT and Network Rail and is seeking a report from the LTB in time for the November SIP.
