Highlight Report No 42 – SIP 27th September 2018

Reporting period

September 2018

Summary Comments

No business cases were approved at the 4th September SIP meeting and the September LTB meeting was delayed until mid October.

The dashboard for Q1 18/19 outputs and expenditure is being submitted to this SIP meeting for approval, prior to submission to Government in October.

The work on the assurance framework has been slightly delayed regarding the requirements of the LEP Review with a meeting held in London late September which will feed into a HotSW LEP paper to be considered by F&R committee.

A meeting took place (MS, EJ, MR) to rationalise content of SIP and F&R meetings with a paper coming to 27th September SIP and F&R meetings for approval to changes to ToRs, which will then feed into an updated assurance framework. In brief, the aim is to focus SIP on external funding and F&R on the LEP's core activities and budget.

A meeting took place on 14th September to highlight processes and actions for PMO, AB and Leadership Groups theme leads, along with project sponsors including in business case approvals, claims, outputs reporting and publicity requirements.

The expenditure profile has been updated to reflect transport projects and this will be updated further and submitted to the November SIP meeting along with the Q2 claims update. The interim update has reduced overspend in 19/20 substantially, moving funding into 20/21. Q2 claims will be reflected in an update for the November SIP meeting.

Growth Deals

Business cases and funding agreements

All GD1 business cases are approved or partially approved – with 3 remaining to finalise information for funding agreement. See table below for details of outstanding actions.

All GD2 business cases are now approved – 15 in total, including 8 in Unlocking Growth Fund. There are also agreements in place for the 3 Growth Hub/Hinkley business support projects which have been delivering for some time.

3 GD3 business cases are approved by SIP - South Devon College, Huntspill and Constructing Futures, plus 2 GD3 transport projects with Programme Entry approval – Huntspill Energy Park and Plymouth Central Station.

11 GD2 agreements (plus the 3 Revenue projects) are signed with others in progress/near signing. 2 GD3 funding agreements are signed.

Budget summary - no update

From Government funding of £197.83m available (not including Forder Valley Link Road) £196.07 + £1.85m has been allocated by the LEP to projects + topslice giving -£0.08m of headroom. However, this is subject to change as Tiverton EUE completes and Jn 25 M5 finalises costs. There is also potential underspend from completed projects spending slightly under budget.

No update - 18/19 Q1 data and forecasts – see detailed expenditure profile sheet attached for more information

This now incorporates finals from 17/18 including resolution of accruals and Q1 actuals for 18/19. The total spend for 17/18 ended higher than reported at £30.77m. Overall slippage has meant previous spend forecast for 18/19 has reduced by around £4m with this split to show increases of around £2m each year for 19/20 and 20/21. Some forecasting has been estimated by PMO where detailed project information is not available and this is indicated on the detail sheet.

Growing Places Fund

Programme Summary

DC Homes –16 claims now paid – this is the last claim for GPF funding but progress claims will continue to be received until project completion.

Progressing on site - Opening further delayed but progress photographs positive and planned to now open in November 2018. Photo opportunity set up for end September. Sedgemoor loan and Deed of Priorities for LEP first charge in place. All further Collateral Warranties now received for review and signing.

Broadband – no update-GPF funding agreement signed Dec 2016 and project mobilisation has begun.

South Yard/Oceansgate - GPF agreement has been further developed following review by PCC lawyers and SIP decision regarding MOD first charge. DCC/Ashfords review meeting held and amends fed back to PCC. PCC have provided further data/attachments and finalisation in progress.

Other projects are on track or complete.

Other projects

Careers Learning Pilot

Roll out ongoing on the Careers Learning Pilot, with three lead partners now under contract for delivery of 1/3 of the programme each in Western Somerset (Somerset Skills and Learning), Plymouth and Torbay (South Devon College) and Northern Devon (Learn Devon). Two work coaches employed in each area, with additional CIAG provision contracted through Prospects. Outputs now slowly being realised, with 300-400 learners secured by the end of August. DfE / ESFA has written out to provider partners last week to offer additional growth, though conditions are being work through. Meeting with DfE to talk through emerging learning points on 20 September.

Careers Hub

Initial hub roll out ongoing, with recruitment underway for posts co-funded by the CEC. This includes named provision / collocated provision within the HotSW's four upper tier areas, as well as a continuation of the Enterprise Advisor programme, and specialist support for HotSW's special schools and the West Somerset Opportunity Area. Three post offered as of 20 September, including Hub Manager role. Launch of provision and new programme currently underway, with a ramp up in late September / early October.

Digital Skills Partnership

Recruitment process is underway. Closing date is Friday 21st Sept. Next meeting is 3rd Oct, when Exeter Uni led evidence report is due. Facilitating HotSW workshop re Digital skills innovation fund on 21st September; DSP reps attending Cyber Skills fund workshop in London.
