Presentation on Social Inclusion by Ian Gent, Managing Director – IG Marketing & Business Development Ltd and Martha Wilkinson, Chief Executive – Devon Community Foundation and LEP Board Director (presentation forwarded to all in advance).

Inclusive growth is a key part of the draft Local Industrial Strategy (LIS); many organisations and studies set out what inclusive growth is, but there is far less available on how inclusive growth can be implemented in economic development. The LEP had previously agreed to adopt the Inclusive Growth Commission's definition of inclusive growth as enabling as many people as possible to contribute to and benefit from the proceeds of growth. The work was commissioned to inform the LEP and wider partnership's approach to this through the LIS.

The full report on Inclusive Growth has already been circulated to the Board.

The presentation was commended for its top-level granularity, the work commissioned assisting towards the evidence gathering for both the productivity plan and the LIS, however it now needs to be translated down into practical what's happening on the ground level, which can sometimes be hampered by the high level chain of command getting in the way of localised effort i.e. the tension in buying local hampered within construction sector procurement. It was noted that initiatives that are already underway i.e. West Somerset Opportunity Area should be considered (WSOA was launched by the government to raise education standards locally, providing every child and young person with the chance to reach their full potential and is focused on improving early years education, improving outcomes at primary and secondary school and helping young people find a good job) this worked on inclusivity and to draw upon the positive lessons already learnt here. The largest barrier to inclusivity is where a person lives and this determines their opportunities for education and employment and presents the biggest challenge to business to find the right staff with the right skills. The WSOA provided a source of funding that helped funding for transport for sixth formers.

Looking at the RSA final report and the recent Centre for Cities study into inclusive growth, successes have come from creating resources from local city assets and where an external source of funding has been forthcoming – perhaps the LEP needs to pursue a dedicated fund via partnership funding i.e. with NESTA (the Innovation Foundation) or the Big Lottery etc.

There needs to be transparency around inclusive growth, and it needs to be front and centre of the LEP's economic vision – the challenge for the LEP is how to deliver an implementation plan to demonstrate this to the wider community.



There was some disparity over current growth statistics, but it was acknowledged that whilst some areas have grown, growth hasn't been shared across the patch.

It was confirmed that the inclusive growth work formed a fundamental part of implementing the Local Industrial Strategy and was not a separate programme or initiative.

Key points recommended to be taken forward

- Study to understand the inclusive growth challenge at a granular level across the HotSW area
- Investigation on whether anchor employers such as the NHS can improve procurement activity to better support inclusive growth
- Investigation on whether some form of Special Purpose Vehicle or similar could be used as part of the implementation

5. Chief Executives Report

Prior to the above report, the CEO gave a presentation (a copy of the presentation was sent out in advance) which focused on the goals he had set himself when he first joined just over a year ago, what achievements had been made, together with thoughts on the challenges going forward and what needs doing differently.

Discussions cont./d and included a call for more timeliness of papers (currently they are normally downloadable from the HotSW LEP website 6 working days in advance of a board meeting, except for late papers); for presentations to be emailed in advance so that they can be read beforehand with a slot of 5 minutes given at the Board to present and the opportunity for questions; more action orientated Board meetings; to look for assistance from Local Authorities (LAs) and Business members to work with the CEO and COO to prepare board papers; to engage more with parliamentary colleagues and ministers with clarity and consistency of purpose on the key asks and to maintain pressure to make priorities happen, utilise local MPs more and keep them appraised of any sticking points (some LEPs get better access to ministers); to review and work with Sir Gary Streeter, MP (Chair of APPG) as to MPs attending the APPG and ensure they are sufficiently well briefed beforehand to enable them to make decisions on the day; the challenges of working across Gov't departments e.g. Defra and BEIS, i.e. Defra leads on the

issue of rural business but BEIS appears to take no account of the impact on rural businesses; LEPs are continually being asked to react to new Gov't initiatives, but when there is push back to question or challenge for further clarification answers are not forthcoming, lessons are not learnt before previous initiatives evaluated, request for Gov't to be more consistent and clearer; no direction from Gov't on devolution policy; continuing frustration with the West of England LEP's lack of will to engage with the



GSW on common cross cutting regional issues (despite numerous attempts) and their formation of the Great Western Powerhouse which risks distancing them further, with the lack of alignment seen by MPs and Gov't as an impediment to future funding for the South West; to have one speaker or high- profile business champion for the region that parliamentarians identify with for the SW to loudly make the political points and act as a champion for the area - perhaps even consider funding a representative in London?

There was also a plea from Mel Squires, NFU Board member, for greater political collaboration between local MPs to progress rural HotSW LEP issues.

Recapping on the Chief Executive's report there were 3 main decisions to be agreed by the Board to: -

- ➤ Sign off Accounts for 18/19 ahead of the AGM (November 4th, Agenda item 6.4
- Next Steps re Growth Hub Agenda item 6.1 (commercially confidential)
- GSW Outline Prospectus

Since writing the CEO report, a further update was given on recent headlines: -

- Additional towns of Glastonbury, Torquay and Bridgwater have been successful from Stronger Towns Funding.
- Connected Devon & Somerset (CDS)'s contract with broadband provider Gigaclear has been terminated.
- ➤ The case for re-opening of Appledore shipyard is continuing favorably with the Rt Hon Geoffrey Cox QC MP and Peter Heaton-Jones MP involved and any assistance that can be given by local MPs to help progress this would be much appreciated.
- ➤ HotSW LEP and Exeter colleagues have met the new management team at Flybe, they have posed some large challenges to the airport area, which will be discussed at a local meeting next week.
- ➤ The Barden Corporation has been turned into a successful outcome from a planned closure, to remaining in situ in Plymouth, with huge effort from Plymouth City Council interceding and with plans to expand and for growth in the area.
- ➤ Brexit and Resilience Group (BROG) there are a series of events across the region planned for Sept/Oct on Brexit related topics sponsored by Dept for International Trade (DIT).
- ➢ Gov't have announced further monies to aid Growth Hubs towards Brexit resilience in order to support SME's − leading on this for the 3 LEPs is Cornwall and Isles of Scilly LEP, with funding to last until the end of March 2020. Funding is appx £180,000 from a national amount of £108m. It is important that the LEPs are clear what the funding will be used for − a package of funding to support SME's post Brexit to those hit hardest. Effective join-up is needed across the different organisations in this space to avoid duplication.

The action from July's board meeting was to write to the Secretary of State and



MPs on the impact to local businesses of a no-deal Brexit, however this was not completed, as it was felt following consultation, that this was not a constructive way forward. Many of the business representative organisations i.e. CBI, FSB have already written and made their views clear on Brexit. The Board reiterated that a letter urgently needs to go out from the LEP, highlighting the major concerns for agriculture and to ports, the issues over business continuity and the continuing uncertainty over business investment, volatility of labour, access to materials and components etc.

Cllrs David Hall and Rufus Gilbert departed the meeting at 12 noon.

Action: The Board to be kept informed on conversations with Cornwall & Isles of Scilly LEP as GH cluster lead on the additional Brexit funding.

Action: A paper is being developed by the BROG group to inform what the LEP would like the additional Brexit GH support monies to be used for and will be available for the Board at the next meeting.

Action: A joint letter from the Chair of the BROG and Chair of the HotSW LEP to be sent to the Rt Hon Andrea Leadsom MP, Secretary of State for Business, Energy and Industrial Strategy outlining the critical challenges of a no-deal Brexit for the area.

<u>Nuclear Sector Deal</u> – a revised submission for the Supply Chain component will be submitted at the end of September, but there is growing concern that this is time critical as the MEH programme tenders start to be awarded and current funding for the Hinkley Deal programme comes to an end in March 2020 which is a huge risk for the supply chain which is reliant on welders from Eastern Europe.

<u>Local Industrial Strategy (LIS)</u> the draft is being reviewed with Gov't departmental officials with the commitments being discussed. Assurance was given that the document has not changed significantly and once all this stage is complete, the document will go to Treasury.

Concern has been expressed from the Tourism Visitor Economy Bodies that there is insufficient reference in the LIS for their sector, although there is an ask for a Tourism Zone, but they feel this is not significant enough.

Action: Draft LIS to be revised to ensure the Tourism sector is sufficiently referenced.

Action: The final revised version of the LIS will be sent out to the Board with an indication of amendments/or summary of changes.
