## 4.2 Growth Deal

Enterprise Zone Update - PH provided a verbal update

SIP previously agreed in spring that the 3 Enterprise Zones in the HotSW LEP area would update their implementation plans.

PH and EJ have been in regular contact with the facilitators of each EZ.

Oceansgate and Exeter and East Devon are progressing well.

Gravity are slightly behind as an emphasis has been placed on creating an LDO and a masterplan to accompany this.

**DECISION**: SIP agreed that there would be a review of the implementation plans and would invite all 3 projects to present them to SIP starting with Gravity in November.



## 4.3 Getting Building Fund (GBF)

3 points of feedback that all projects will receive are;

- Re-evaluation of job outputs having received definitions/guidelines from Central Government
- State Aid compliance needs to be addressed and evidenced by the project before being able to proceed to signing a funding agreement
- All projects will need to follow MHCLG communication policy

During the discussion a number of conditions around topics such as outputs and state aid arose. It was agreed that these would be approached consistently across all projects during funding agreement development.

Committed to £35.4m worth of projects proceeding to funding agreement with about £2m left to spend with 6 reserve projects to be reviewed at the next SIP meeting.
