Highlight Report No 61 - SIP March 2021

Reporting period

January/February 2021

Summary Comments

At the January SIP meeting 2 further Getting Building Fund (GBF) projects were reviewed - 1 requiring a revised business case – Smart Biosphere and the other progressing to funding agreement, East Quay. A 3rd project considered in the event of residual funding, Dunball Junction, was approved subject to a full business case.

Clarity was requested around an aspect of the Plymouth Railway Station Growth Deal 3 project relating to the freedoms and flexibilities of Plymouth City Council and a funding arrangement with University of Plymouth. Subsequent to the SIP meeting, this was provided by email and SIP Members were in agreement to proceed on this basis.

Subsequent to the January SIP, decisions have been made on variations to business cases on GBF in order to keep momentum in project funding agreement and delivery. This includes an approval for the revised business cases for Smart Biosphere and Zebcat 2.

SIP also agreed a process for inward investment funding decisions by email.

On Growth Deal, some minor variations have been approved by email or to be submitted to the March SIP to enable expenditure by end March, including the use of Freedoms and Flexibilities, including Digital boost, Digital accelerator and Plymouth 5G Smart Sound due to be reviewed. Houghton Barton transfer of funds to A382 is approved by email as at today's date.

On GD3 - CDS GD3 is now the only business case outstanding.

The Q3 20/21 total LGF spend as per the dashboard submitted to government and including freedoms and flexibilities was £11.3m, ahead of forecast for the quarter, bringing cumulative spend to approx. £182.7m.

Outputs for Q3 have also been submitted with a full reconciliation to take place as part of Q4 year-end activities.

Growth Deals

Business cases and funding agreements

All GD1 business cases are approved or partially approved. All GD2 business cases are now approved and funding agreements signed. On GD3 - CDS GD3 is now the only business case outstanding.

Delivery

At end Q3 20/21, 45 capital projects have completed spending their Growth Deal funding. We have 16 live capital projects to complete expenditure in 20/21 with no live issues raised currently. Theme leads are working on ensuring Q4 claim submission is as expected. Attached spreadsheet summary shows the position.

Monitoring will continue as per the projects' Monitoring and Evaluation Plans but we are expecting some outputs delays with live projects, due to social distancing measures etc.

Budget summary - At Q3 20/21 (no update)

At end Q3 20/21: **Of govt allocation of £197.83m, £182.77m** has been spent and **£15.06m** approx. is remaining to spend in 20/21.

Headroom of approx. £0.54m is currently being used as underwriting for the Growth Hub, so is not available for reallocation.

Getting Building Funding (GBF)

This means we have 24 projects in total with a further project progressing for a March decision to utilise residual funding. Funding agreements are completed for 18, 3 are awaiting signature and 4 awaiting approval. Project expenditure is permitted from the announcement on 4th August 2020.

Theme leads have been allocated to work with projects, SCC and PMO to work through the conditions and complete the full complement of signed funding agreements.

Budget summary at end Q3 20/21

Of govt allocation of £35.4m, £0m has been spent and **£17.7m** approx. is remaining to spend in 20/21. Currently £35.275m is allocated to projects. Unable to provide detailed forecast until all funding agreements have been signed. We will use the Freedoms and Flexibilities to complete the full 50% target by end March 2021.

Growing Places Fund (no update)

DC Homes – A repayment variation request was received in March 2020, prior to COVID lockdown. Due to lockdown and ongoing COVID restrictions the project was given a repayment holiday until March 2021. A revised variation request will be requested early in 2021 for review and consideration by the SIP for arrangements post April 2021.

Millfields – **Genesis Centre.** Due to lockdown and ongoing COVID restrictions the project was given a repayment holiday until March 2021. A revised variation request will be requested early in 2021 for review and consideration by the SIP for arrangement April 2021 onwards.

Broadband – GPF funding agreement signed December 2016 and project mobilisation has begun. A request to accept an amended expenditure profile has recently been reviewed and agreed by SIP this will extend the repayments until 2023/24.

Other GPF projects are in repayment, repayment holiday or complete.
