4	Overview of LEP Finances	
	his was presented by Richard Stevens, HotSW LEP Board member and Chair of the LEP's Business Leadership Group standing in for David Bird.	
in th	financial statement was shown (taken from the Annual Report) with tables showing the ncome and expenditure for the year on the core operational budget held by the HotSW LEP, he Operational Reserve, HotSW Growth Deal budget, HotSW Capacity Projects, European tructural Investment Funds and projected future funding budget.	
U re	The financial slides are available on the LEP's website. Highlights were:- Jnder <i>income,</i> this included a grant from Gov't for an additional £200k to respond to the LEP eview, plus under additional local area contributions this represents a top slice towards LEP unning costs.	
2 0	Under expenditure, the difference between salaries and expenses between 2018/2019 to 2019/2020 is reduced because there are no overlapping salaries of Chief Executive costs. The other area of significance in 2019/2020 is the introduction of an Enabling Fund to accelerate Enterprise Zone delivery.	
	In conclusion, at the end of this financial year, there was a small draw on reserves as opposed to a surplus last year.	
LE fc	Reserves slide – nothing notable to mention and represents the money that is used to run the EP with general reserves providing the future running costs of the LEP and earmarked reserves or specific projects being delivered by funding through the LEP e.g nuclear supply chain. The LEP has sufficient reserves for the future running of the LEP and to meet its commitments.	
th re	<i>Future expenditure</i> – the LEP has no long-term certainty over core funding from Gov't and herefore has to assume two scenarios:- a) with Gov't funding and b) without Gov't funding. In eality, the 21/22 shortfall shown would be eliminated by either a) adjusting 21/22 expenditure or b) receipt of core grant in 21/22.	
A a Ll T	5. Adoption of Accounts As the HotSW LEP CIC is a dormant company, accounts that are filed with Companies House are a zero balance. All our monies and grants flow through Somerset County Council which is the EP's Accountable Body with Section 151 Officers providing oversight of the LEP's activities. The accounts have already been adopted and approved by LEP Board and are just for reference.	



6. AOB & Questions

Attendees registering for the LEP AGM Webinar were asked to submit questions in advance, however, non were submitted.

The following comments came in on the day via the webinar chat facility and are posted below. All answers were responded to the individual raising them and all questions and answers were anonymised and published on the LEP's website following the AGM.

No sign of the rich cultural life of our region in the video - will this be a priority going forward?

The short video primarily focussed on LEP investments over the last 12 months but the cultural and natural environment of our area is a key part of what makes this area distinctive both for quality of life and underpinning key industries such as the visitor economy, food & drink, etc. The LEP recognised this in the 2018 Productivity Strategy and more recently in the draft Local Industrial Strategy.

It nay be worth clarifying, salary reduction caused the total salary bill to be £469k... it wasn't that the CEO's salary alone was reduced to £469k.

That is correct. The LEP's <u>total</u> salaries & expenses cost reduced from £522k in 18-19 to £469k in 19-20. This was because in 18-19 there was a period of overlap between the retiring and incoming Chief Executives to ensure a smooth handover.

Has the Government provided any signals about future funding?

Gov't has proposed a UK Shared Prosperity Fund as part of the replacement for funding previously delivered through the EU but more details are yet to be set. EU funds were only one funding stream that supported economic development in the Heart of the SW area. Gov't has also stated its intention to publish a devolution and local recovery white paper in a few weeks and more details might be set out there.
